Keynote Speaker: Charlotte Lanvers
Trial Attorney, Disability Rights Section, Civil Rights Division, U.S. Department of Justice

Ms. Lanvers has been a trial attorney with the Disability Rights Section of the Civil Rights Division at the U.S. Department of Justice since 2014 where she has worked to enforce Titles I, II and III of the ADA. From 2012-2014, Ms. Lanvers worked as an attorney in the Program Legal Group at the Office for Civil Rights in the U.S. Department of Education. Prior to that, Ms. Lanvers worked as a Skadden Fellow and Staff Attorney at Disability Rights Education and Defense Fund in Berkeley, California.

Attorney Lanvers will address the significance of the ADA anniversary, voting rights protections in the ADA and other federal laws, and the requirements in federal law to include equitable access to voting for people with disabilities.
