

Make Your Home Energy Efficient to Save Money



Thanks to the partnership of Wisconsin's Public Service Commission, Revitalize Milwaukee, and Green Homeowners United, residents over 60 or with a disability can access grants, tax credits and more to affordably reduce carbon emissions, save on energy and make the home more comfortable, here's how:

For those eligible (see below) you can qualify for:

- Grant of \$7,800 on average to insulate attics, make the home feel less drafty, and save energy!
- Support applying for new funds from the Inflation Reduction Act in 2023 to install high efficiency air conditioner "heat pumps" that can both cool and heat the home.
- OPTIONAL - Low-interest financing available for residents of Milwaukee (City only), West Allis or Waukesha County for larger energy saving or repair projects such as insulating basement walls or upgrading windows. Insulating basement walls makes it brighter, dryer, warmer, more finished looking, and saves money.

Available to the first 40 residents that successfully enroll!

Eligibility requirements: To qualify, you must meet the following requirements

- You must be EITHER (1) over 60 years of age, (2) be a veteran, or (3) have a disability, AND
- You must own the home, be for primary residence, up to date on property taxes & not in foreclosure.
- You must earn less than the following amounts. (Note, partial grants may be available for those above listed income)

STEP 1 – Call *Green Homeowners United* or Revitalize Milwaukee for eligibility: 414-604-6418

STEP 2 – Have a trained energy expert from *Green Homeowners United* visit your home to talk with you about which improvements would have the largest impact on energy use

STEP 3 – Decide together with *Green Homeowners United* which improvements you would like to include, and turn into a full proposal to maximize the programs available to you

STEP 4 – *Green Homeowners United* or Revitalize Milwaukee can help you fill out the applications* and let you know which income and tax paperwork to gather for consideration.

STEP 5 – After the project proposal is approved, Revitalize Milwaukee approved contractors such as *Green Homeowners United* will perform the work directly on your home, around your availability!

* - This work is made possible by funding provided by the Wisconsin Public Service Commission, Revitalize Milwaukee, Focus on Energy and the US Department of Energy. As such, there will be a few applications to fill out together. *Green Homeowners United* will guide you through them all. Additional restrictions may apply. Revitalize Milwaukee or *Green Homeowners United* reserve right to determine a home may not be eligible for additional reasons, such as health & safety concerns. While funds are available.
