## Qhia Tawm

Peb nquag hu koj tuaj raws koj lub tsev kawm ntawv txog cai txog kev thab plaub thiab muab hais qhia koj kev txhawj xeeb nyob rau kev sau ntawv. Yog lub tsev kawm ntawv tsis paub txog kev thab plaub tshwm sim, lawv yuav muaj qhov tsawg rau yam lawv tau los pab.

Yog tias koj tus me nyuam ntsib teeb meem rau kev thab plaub saib tsis tau raws li lawv kev xia hoob khab, haiv neeg, cev nqaij daim tawv, los sis kev tuaj lwm lub teb chaws tuaj, koj yuav hu rau chaw (Department of Public Instruction Non-Discrimination Coordinator) tus tuav kev saib tsis tau no thiab/los sis sau ib daim ntawv tsis txaus siab nrog lub hoob (Office for Civil Rights) nyob rau tsoo fwv tsev kawm ntawv.
