

Fact Sheet: Bullying

Introduction

We encourage you to follow your school's bullying policy and formally report your concerns in writing. If the school is not aware bullying is happening, they are limited in what they can do to help.

If your child is experiencing bullying based on their disability, race, color, sex, or national origin, you may contact the Department of Public Instruction Non-Discrimination Coordinator and/or file a complaint with the Office for Civil Rights with the federal Department of Education.

Additionally, complaints alleging a violation of Section 504 or the ADA relating to education may be filed with the U.S. Department of Education, Office for Civil Rights (OCR).

2. The Office for Civil Rights is an office of the Department of Education and serves students facing discrimination in their education. The OCR's mission is "to ensure equal access to education and to promote educational excellence through vigorous enforcement of civil rights in our nation's schools."

Should you file with the OCR, a complaint must be filed within 180 days of the violation or the day the incident occurred.

It's also important to keep in mind that schools are very limited on what information they can provide to parents or information regarding any action involving another student due to the Family Educational Rights and Privacy Act (FERPA). It is also beneficial to be aware of related polices such as your school's anti-harassment and anti-discrimination policies.

School staff, parents, and other caring adults have a role to play in preventing and responding to all forms of bullying. If a student with a disability is being bullied, federal law requires schools to take immediate and appropriate action to investigate the issue and, as necessary, take steps to stop the bullying and prevent it from recurring.
