

# Fact Sheet: Wisconsin Public Schools Open Enrollment Resources

## Introduction

Wisconsin pupils with disabilities can and do participate in open enrollment. There are two ways to apply for open enrollment:

1. Standard application for the following school year, during a 3-month period from February to April.
2. Alternative application for the current school year, which can be done under seven special circumstances.

A pupil may not be denied open enrollment because the pupil is a child with a disability nor based on the category of the disability. However, any open enrollment application may be denied if the nonresident school district does not have space for the pupil.

1. Children with IEPs: For a child with a disability, this includes availability of and space in the special education program as written in the pupil's individualized education program (IEP).
2. Section 504 Plans: Pupils eligible under Section 504 can only be denied open enrollment for the same reasons that a non-disabled pupil can be denied.

If an IEP is developed or revised for a pupil already attending a nonresident school district, the nonresident school district may re-examine whether it has the special education and related services available for the pupil. If not, the nonresident school district may notify the parent and the resident school district that the pupil must return to the resident school district. If the nonresident school district does have the special education and related services needed available for the student, the nonresident school district must offer a placement to the parent.
