

Fact Sheet: Snow Removal

Housing (Apartments, Condos, Etc.)

Process for Residential Issues

- Submit a formal request for an accommodation regarding the snow removal issue and how it relates to your disability to your landlord or property manager.
 - ➤ It is important to include supporting medical documentation with your request.
- Document incidents and correspondence with dates and times.

If the issue is not resolved in a timely manner, you can file a formal complaint with the following entities:
