**Q: Kuv tsis xav tau ib tug neeg them sawv ce (rep payee), tab sis tseem nrhiav ib tug rau kuv thiab. Kuv yuav tsum ua li cas?**

Yog koj tsis pom zoo tias koj yuav tsum xav tau ib tug sawv cev (representative payee) los sis xav hloov koj tus (representative payee), nws yog ib qhov xav kom koj hu rau SSA lub hoob kas nyob rau 60 hnuv (txog li 2 hlis) los qhia txog kev txiav txim ntawd.

**Q: Kuv tus sawv cev them (rep payee) nyiaj txiag ntawd tsis siv kuv li nyiaj kom raws li kev li kev cai. Kuv yuav ua li cas?**

Yog tias koj tsis pom zoo koj tus sawv cev (representative payee) siv koj li nyiaj los sis yog koj ntseeg tias muab koj li nyiaj siv raws cai lawm, hu rau (SSA) lub hoob kas los sis Tug Neeg Kuaj Xyuas (Inspector General).

Them tau nyiaj tshaj lawm tshwm sim thaum koj tau txais nyiaj ntau los ntawm (SSA) raws li qhov lawv yuav tsum them rau koj.

### **Q: Yuav qhia rau kuv li cas yog tias kuv raug them tshaj lawm?**

Daim ntawv them tshaj yuav piav vim li cas koj thiaj raug them tshaj lawm, koj them tshaj yog pes tsawg, koj qhov kev yuav tau them rov qab li cas thiab koj kev paub txog rau hais plaub ntug thiab tso cai rau. Lub hoob kas (SSA) xav tau tias koj tau txais daim ntawv tsib hnuv tom qab muab xa rau koj tsuas yog koj muaj pov thawj xwb. Qhov kev rho los ntawm SSI yuav tsis tshwm sim li 60 hnuv tom qab daim ntawv xa tuaj no.

### **Q: Yog tias kuv ntsib teeb meem rau kev sib tiv tauj rau kuv lub hoob kas?**

### **Q: Yog tias lub (SSA) muaj kev ntxub ntxaug rau kuv?**
