Ntuav Tawm

Cov tsev kawm ntawv yuav tsum kom los nrhiav saib xyuas cov me nyuam uas muaj cov kev xiam hoob khab thiab ntsuam xyuas rau qhov kev pab kawm (special education) tau txais no. Phau ntawv qhia (guide) no yuav pab ntaub ntawv rau cov niam txiv txog kev pab cuam (special education) xav rau, cov kauj ruam ntsuam xyuas, thiab lwm yam kev pab thiab yog tias tus tub ntxhais nrhiav tau “tsis tau txhais” rau qhov kev pab (Individualized Education Program, IEP).

Xa Mus Rau Lwm Qhov Pab

Nyob rau hauv tsab cai (Individuals with Disabilities Education Act IDEA), cov tsev kawm ntawv yuav tsum kom muaj qhov hu "Me Nyuam Nrhiav "(Child Find), uas yuav tsum kom cov tsev kawm ntawv los nrhiav thiab ntsuam xyuas kev pab cov me nyuam nrog kev xiam hoob khab yuav tsum tau kev kawm (special education) thiab lwm yam kev pab cuam ntawd.

Qhov kev txheej txheem pib nrog ib xa rau tus me nyuam lub koos haum (Local Education Agency, LEA), uas yog tus me nyuam lub tsev kawm ntawv los sis tsev kawm ntawv ntiav (charter) lawv kawm ntawv ntawd. Ib tug tub ntxhais uas tsis tau txais qhov kev pab rau qhov (Individualized Education Program) tej zaum yuav tau txais rau qhov sau **“504 plan”** nyob hauv qab Nab (Section 504) ntawm tsab cai (Rehabilitation Act of 1973). Nab (Section 504) tiv thaiv cov tub ntxhais kawm ntawv nrog kev xiam hoob khab los ntawm tsis pub kev ntxub ntxaug. Meej tseeb li, Nab (Section 504) tiv thaiv cov tub ntxhais kawm ntawv nrog “ib cev puas los sis muaj mob kev nyuaj siab uas rau lawv ua tsis tau li ib los sis ntau dua kev ua hauv lub neej.” Kev ua si hauv lub neej suav ntxiv kev kawm, kev rau siab ib yam twg, kev xav, thiab kev tham, raws li kev ua si xws li mus kev los sis noj zaub mov.
