#### Appealing a Children's Long Term Support Denial

## What Happens When You Request an Allowable Service or Item?

When a Children's Long-Term Support program participant requests – either verbally or in writing – an allowable service or item, the County should make a decision within **14 calendar days**.

- If approved, the County should add it to the child's Individual Service Plan (ISP). Find a blank Individual Service Plan here:

- If denied, the County should provide a written Notice saying what was denied and how to appeal by filing a request for state fair hearing. If no written notice is provided, program participants may request a written Notice be sent to them.
