Lub Chaw (Division of Vocational Rehabilitation / DVR) yog Dab Tsi?

Lub Chaw (**Division of Vocational Rehabilitation**) yog ib qhov kev pab txhawb nqa cov ib leej twg nrog muaj kev xiam hoob khab puas tes puas taw los nrhiav hauj lwm, kaw tau hauj lwm, los sis kom tau txoj hauj lwm zoo dua tuaj. Lub (Division) yuav pab koj nrhiav ib txoj hauj lwm uas yuav haum rau koj cov kev txwj ntse (skills) thiab cov peev xwm (abilities) los pab cuam dhaw tej yam-kev nyuaj ntawd.

Kuv yuav nrhiav tau li cas tias kuv yuav tau txais DVR cov kev pab cuam?

Koj yuav tau txais kev pab hauv lub (Division of Vocational Rehabilitation) cov kev pab cuam yog tias koj kev xiam hoob khab puas tes puas taw tswv koj los nrhiav tsis tau los sis tuav tsis tau ib txoj hauj lwm. Koj los sis koj niam koj txiv los sis tus saib xyuas koj (guardian) muaj cai thov kev pab pib li thaum hnuv nyoog 14 xyoos ntawd. Koj xav kom ua tau sai dua rau koj kev pab los sau ntaub ntawv rau koj lub chaw hauj lwm (Division of Vocational Rehabilitation) Cov Kev Pab Cuam.

Lub chaw (Division) yuav txais cov ntaub ntawv zoo li:

- ▶ Cov ntaub ntawv kho mob
- ▶ Cov ntawv los ntawm koj tus kws kho mob qhia txog koj tus mob nkeeg
- ▶ Nyiaj (Social Security Administration / SSA) cov kev pab cov ntaub ntawv
- ▶ Cov ntaub ntawv tau txais kev pab
- ▶ Daim ntawv npaj (Individualized Education Plans / IEPs)

Lawv yuav nug koj los kos ib daim ntawv tso cai (release form) ces lawv thiaj yuav tau cov ntaub ntawv kho mob. Yog koj ua tsis tau tiav los sis cov ntaub ntawv txog koj kev xiam hoob khab puas tes puas taw, koj yuav tau nug txog rau lub (Division of Vocational Rehabilitation) tuaj ntsuam xyuam.

Yuav siv sij hawm ntev li cas los nrhiav tau seb kuv puas yuav tau txais cov kev pab cuam no?

Lub chaw (Division of Vocational Rehabilitation) muaj **60 hnuv** los txiav txim seb koj puas tau txais cov kev pab cuam no. Qee zaus yuav siv sij hawm ntau dua – piv txwv, yog tias lub (Division of Vocational Rehabilitation) xav tau cov ntaub ntawv kho mob ntau dua, los sis lawv tseem tsis tau pib los sis ua tiav cov kev ntsuam xyuas rau kev txiav txim rau kev pab cuam no. Yog tias qhov tshwm sim, lub (Division) yuav tsum hu rau koj los tham txog kev ntxiv sij hawm los tshawb cov ntaub ntawv no. Lub (Division of Vocational Rehabilitation) yuav xa koj ib tsab ntawv qhia rau koj seb koj puas yuav tau txais cov kev pab cuam no.

Yog tias kuv raug tias kuv tau txais (DVR) cov kev pab cuam, dab tsi yuav tshwm sim ntxiv mus?

Thaum (DVR) txiav txim siab tias koj tau txais cov kev pab cuam no lawm, lawv muaj 90 hnuv lost sim koj daim (person-center plan) – hu tias **daim (Individual Plan for Employment / IPE)**.
