**Yog tau,** koj nug tau kev hloov cov neeg ua hauj lwm (counselors). Koj muaj cai xaiv txog koj kev kho ntawm (Division of Vocational Rehabilitation/DVR) cov kev pab cuam uas pab tau koj tus kheej. Qhov no suav ntxiv rau kev txiav txim txog cov neeg ua hauj lwm rau koj nrog rau kom mus txog koj cov hom phiaj.
