



▶ Form Letter: Asking Your Landlord for an Assigned Parking Space

This form letter shows what can be in your letter to your landlord or property manager. It is not legal advice. For legal advice specific to your situation, please talk with an attorney.

About This Form Letter

You may use this letter to ask your landlord to give you an assigned parking space as a reasonable accommodation. You can do this by explaining your disability and why you need an assigned parking space because of your disability.

How to Use This Form Letter

Filling Out the Letter

You can type your information into this form letter using your computer and print it out. If you don't have a computer or can't use one, you can print the form letter out and fill it in by hand.

Reasonable Accommodations Under the Fair Housing Act

You may send the letter with a memo from the U.S. Department of Justice (DOJ) and U.S. Department of Housing and Urban Development (HUD). The memo explains housing providers' duties under the federal Fair Housing Act (FHA), including how to handle reasonable accommodation requests like this one.

Medical Documentation

You may send the letter with **medical documentation** that supports your request for accommodation. Medical documentation can be letters from a medical doctor or other provider or practitioner with knowledge of your disability and related needs.

Time to Reply

You may want to ask the landlord for a response within 1-2 weeks. This will give them time to reply to your letter.

Sending Your Letter

Once you have filled out the letter, you can mail it, email it, or drop it off with your landlord. Keep a copy of the letter for yourself. You can write down when you sent your letter and when you are expecting a reply.
